2019-2020

1. Fill out the online application.
2. Submit the completed application to the Board.
3. Submit your (non-refundable) application fee of \$85. When inducted into EBG, the balance of the dues for the current quarter will be pro-rated.
4. Include a Typed Bio of your company (tell us about your company, products and services).
5. Include a Bio of you (tell us about yourself, married, kids, education and/or experience).

## The Application Process Includes:

Up to three weeks for the committee to make a decision whether to include your company as a member (we strive for a quicker response).

1. The \$8 entry fee to the meetings is waived during these 2 weeks.
